further sum of THREE DOLLARS, to us the said mortgagor S.,  
in hand, well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,  
we the said mortgagor S. Have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release  
unto the said mortgagee:

All that certain piece ~~piece~~ or tract of land,  
situate, lying and being in the State and County,  
aforesaid, on the West side of the Suber Road,  
adjoining lands of L. C. Copeland, Southern Railroad  
and Mrs. Ellie S. Hawkins, and being the same  
tract of land conveyed to us by Mrs. Ellie S.  
Hawkins by deed recorded in P. M. O. Office for  
Greenville County, in Vol. 187, page 253, and having  
the following courses and distances, to-wit:

Beginning at an iron pin in the center of the  
Suber Road, thence ~~thence~~ thence 87.9 feet to an  
iron pin on the Copeland line. Thence with the  
Copeland line 840.21 feet to an iron pin on  
line of part of the signal light tower line, thence  
N. 85-05 E. 87.3 feet to an iron pin on the side of the  
Suber Road; thence with the said road N. 20-45 W.  
401 feet to an angle in the center of said road; thence  
N. 26-45 W. 200 feet to center of said road; thence N.  
25-00 W. 100 feet to center of said road; thence N 17-05  
W. 209.5 feet to the beginning corner, containing  
Twelve and ninetytwo one-hundredths (12.92) acres,  
more or less.
