debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said

property of R. W. Matheny, made by R. E. Dalton in June, 1935 and having the following metes and  
bounds, to-wit:

Beginning at an iron pin on the Southeast  
side of Edisto Street, 35 feet from Brookview Circle,  
corner of Lot No. 37, and running thence with the  
Southeastern side of Edisto Street, N. 48-38 E. 100 feet  
to an iron pin, corner of Lot No. 40; thence with  
the line of said lot, S. 41-22 E. 154.9 feet to an
