all that certain piece, parcel or lot of land,  
with the buildings and improvements thereon,  
lying and being in the City of Greenville, County  
of Greenville, State of South Carolina, known and  
designated as lot No. 5 on plat of property of C. M.  
and C. S. Herrell made by H. Olin Jones February  
1913, and having, according to said plat which is  
recorded in the R. M. L. Office for Greenville County,  
S. C., in Plat Book 6, at page 62, the following lines  
and bounds, to-wit:

Beginning at a point on the west side of Mallard  
Street, said point being 121.2 feet north from the north-  
west corner of the intersection of Teanbar and Mallard  
Streets, and running thence N. 76-21 W. 166.5 feet to a  
stake, thence N. 18-39 E. 60.6 feet to a stake, thence S.  
76-21 E. 169.7 feet to a stake on the west side of said  
Mallard Street, thence along the west side of said  
Mallard Street, S. 21-44 W. 61 feet to the beginning  
corner. Being the same lot conveyed to the mortgagor  
herein by deed of Ella M. Herrell and Eugenia D.  
Herrell, dated April 2, 1923 and recorded in the R.  
M. L. Office for Greenville County, S. C., in Deeds  
Volume 58, at page 130.
