all that certain lot of land in ~~which~~ *Springs* Township, said State and County, near the city limits of *Greenville*, and designated as *Lot #5* on plat of property of *H. L. Smith* prepared by *H. S. Brockman* on *May 25, 1936*, and thereon delineated as follows:

Beginning at a pin on eastern edge of *Pelham Street* corner of *Lot #4*, and runs thence with line of *Lot #4* *S. 35-04 E. 170* feet to point, thence *S. 34-56 W. 60* feet to pin, thence *N. 55-04 W. 170* feet to edge of *Pelham Street*, thence with said *Pelham Street* *N. 34-56 E. 60* feet to the point of beginning, with an additional strip on the *south* or *southwestern* side of said lot measuring on its *front* line on *Pelham Street* and the rear line six feet, with a depth of *170* feet on the two side lines and adjoining said *Lot #5* on the *south* or *southwest*, and being the same lot of land conveyed to me by *H. L. Smith*.
