TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Caro Abernethie, of Greenville County SEND GREETING:
WHEREAS, I the said Caro Abernethie

in and by my certain promissory note, in writing, of even date with these presents, and well and truly indebted to FIDELITY FEDERAL SAVINGS
AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Four Hundred and

no/100 (\$ 400.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Eight (no/100) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Caro Abernethie

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said Caro Abernethie in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Butler Township, on the south side of Laurens Road, near the city of Greenville, being shown as lot no. 6 on plat of property of St. St. Halcombe, dated April, 1930, made by Stetson & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in Book "4" at Page 173, and having, Obtaining to said plat, the following metes and bounds: 35-200-786 Beginning at an iron pin on the south side of Laurens Road, corner of lot no. 5, and running thence with the line of said lot, S. 34-45 E. 200 feet to an iron pin in line of property now or formerly owned by The Sinking Fund Commission of School District #17-A; thence with the line of said property S. 50-15 E. 72 feet to corner of lot no. 7; thence with the line of said lot, N. 34-45 E. 200 feet to an iron pin on Laurens Road, thence with the southern side of Laurens Road, N. 50-15 E. 72 feet to the beginning corner; said promise being that conveyed to Caro Abernethie by St. St. Halcombe by deed dated March 21, 1930, and recorded in the R. M. C. Office for Greenville County, vol 5, 1930, in Book of Deeds "57" at Page 130.
