Whereas, I the said S. B. Capell SEND GREETINGS:

in and by my certain promissory note in writing, of even date with these presents, and  
well and truly indebted to F. M. Gifford

in the full and just sum of one hundred  
(\$100.00) Dollars, to be paid one year after date

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid

semi-annually until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, about three miles East of Greenville Court House on the north side of Lowndes Hill road, and having the following metes and bounds, to-wit:

Beginning at a stake on the Lowndes Hill Road, corner of land now or formerly of Arch Jamison, and running thence N. 16 W. 548 feet to center of C. & W. C. Railroad; thence along said C. & W. C. Railroad N. 76-30 W. 119.5 feet to a stake; thence S. 16 E. 597 feet to Lowndes Hill Road; thence with Lowndes Hill Road N. 79 E. 100 feet to the beginning corner.

Also that other tract of land in Butler Township, Greenville County, State of South Carolina, on the Woods Crossing Road and immediately adjoining the first described tract, and being more fully described as follows:
