all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina.

All that certain parcel or tract of land lying and being on the Southwest side of the Cedar Land Road about three and one-half miles from Greenville containing 12.97 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Cedar Land Road at the corner of the Wynne property where a branch crosses the road and thence running up the meanders of said branch approximately S. 9 W. 5.60 to a maple stump at the fork of said Branch; thence up with meanders of said branch along the Wynne property approximately S. 51 W. to a stone at the corner of property conveyed to G. W. Cureton and J. C. Martin; thence along the line of this said property S. 43 1/2 E. 14.50 to a point on a branch; thence down the meanders of said branch to a point where the driveway from the Cedar Land Road to the dwelling crosses the said branch; thence in a Northeasterly direction in a straight line to a point at a bend in the Cedar Lane Road; thence along the Cedar Land Road N. 46-3/4 W. 4.50 to a bend; thence still along the Cedar Land Road N. 20 W. 5.00 to the beginning corner, and being a portion of a tract conveyed to Mrs. M. B. Cureton by R. Y. Hellams on October 24, 1892 by deed recorded in Volume YY, at page 559. The said Mrs. M. B. Cureton having devised the property unto J. S. Cureton who in turn devised it unto Annie W. Cureton for life with remainder to Hugh B. Cureton. The said Annie W. Cureton having conveyed her life estate unto Hugh B. Cureton by deed to be recorded.
