- (2) The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance.
- (3) Nobuilding costing less than Seventy-five Hundred (\$7500.00) Dollars shall be erected upon said lot other than out buildings appertaining to a dwelling.
 - (4) The property shall be used exclusively for residential purposes.

The grantor herein agrees to hold the part of her property above described subject to the restrictions contained in this deed, and to incorporate them in any deed to any part of said property executed by her and any conveyance of any part of said property by her is hereby declared to be subject to said limitations and restrictions.
