WHEREAS, I the said Fannie B. Hand

in and by my certain promissory note, in writing, of even date, with these presents, I am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Two Thousand, Two Hundred & No/100

(\$ 2,200.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Twenty-Two and No/100

C. office for Greenville County in Plat Book F, at page 96, and having, in the aggregate, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Laurens Road, at the northeast intersection of said Laurens Road and Montevista avenue and running thence along the east side of said Montevista avenue, N. 55-55 E. 198.7 feet to an iron pin, corner Lot No. 4; thence along the line of Lot No. 4, S. 55-26 E. 128.2 feet to an iron pin, rear corner of Lots 2 and 3; thence along the joint line of said lots, S. 21.-53 W. 199.4 feet to an iron pin on Laurens Road, corner Lots 2 and 3; thence along the line of said Laurens Road, N. 55-45 W. 135.6 feet to the beginning corner.
