NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagee to hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release

unto the Mortgagee, its successors and assigns, the following described real estate situated in the county of Greenville State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, near the City of Greenville, known and designated as Lot No. 59, of North Hills, according to a plat recorded in B. M. C. Office for Greenville County in Plat Book H, at page 158, and having the following metes and bounds:

BEGINNING at a point on the north side of Gallivan Avenue, 71 feet west of the northwest corner of Bennett and Gallivan Avenue, and running thence N. 71-43 W. along Gallivan Avenue 71 feet to an iron pin; thence N. 19-17 E. 170 feet to an iron pin on a 20 feet alley; thence with said alley S. 74-43 E. 71 feet to an iron pin; thence S. 19-17 W. 170 feet to the point of beginning.


