McDaniel, individually and as guardian of Nora Camille McDaniel and Helen Carroll McDaniel, does hereby release and forever discharge the property hereinafter described from the lien of that certain mortgage held by me covering said premises, said mortgage being in the original sum of \$ 18,400.00, dated November 3, 1936, recorded November 3, 1936, in office of R. M. C. for Greenville County in Vol. 259 at page 288.

This release is made pursuant to the provisions of the decree dated November 3 1936, filed in the case of Helen B. McDaniel, individually etc. against Nora Camille McDaniel, et al, as will more fully appear by reference to Judgement Roll E-6100 on file in the office of the Clerk of Court for Greenville County.

The premises hereby released are described as follows:

M. C. for Greenville County in plat Book D pages 226 and 227, and being a portion of the property conveyed to R. M. Caine and Calvin F. Teague, by Helen B.
