

## MORTGAGE OF REAL ESTATE

Know All Men By These Presents:

That, Walter A. Williams, Jr. of the City of Richmond, Virginia, holder of a certain mortgage given by Mortgage Corporation of Virginia to Walter A. Williams, Jr., recorded in Mortgage Book 183, page 307, in the office of the Register Meane Conveyance, Greenville County, South Carolina; given to secure the sum of Two Thousand Two Hundred Four and 93/100 Dollars (\$2,204.93) evidenced by one certain promissory note, upon the following described property, situate, lying and being in Greenville County, State of South Carolina, to-wit:

Beginning at an iron pin on the Northwest side of Franklin Road, which iron pin is 80 feet northeast of the intersection of Grove Street and Franklin Road; and running thence with the Northwest side of Franklin Road, N. 45-26 E. 80 feet to an iron pin; thence N. 44-20 W. 199 feet to an iron pin; thence S. 43-20 W. 80 feet to an iron pin; thence S. 44-20 E. 196.5 feet to an iron pin in the northwest side of Franklin Road, the point of beginning. Being the same lot of land conveyed to Ralph K. Stansell by deed of Joseph A. McCullough, dated December 8, 1923, and recorded in Volume 57, Page 563.
