BEGINNING at an iron pin on the Southeast corner of Whitsett Street and Boyce Avenue, and running thence South 15 degrees East 126 feet, 1 inch along Boyce Avenue, to an iron pin on a 10 foot alley; thence along said alley North 76 degrees, 45 minutes East, 71 feet, 8 inches to an iron pin on the North side of said alley, being the joint corner of Lots Nos. 1 and 2; thence North 15 degrees West, 126 feet, 1 inch, to an iron pin on the South side of Whitsett Street; thence South 76 degrees, 45 minutes West 71 feet, 8 inches, along Whitsett Street to the beginning corner, and being designated as Lot No 1 of Block 9 as shown on Plat by J.
