Eva H. Anderson and Eunice J. Andrea. All of my right, title and interest, the same being an undivided two-thirds interest in and to all that tract or lot of land in Oaklawn Township, Greenville County, State of South Carolina.

about two miles North of Fork Shoals Factory on the East side of the Fork Shoals-Greenville Road, and bounded by lands of Hopkins, Cureton, Medlock and said road, and has the following metes and bounds, to-wit:

BEGINNING at a stake in the branch, J. G.
