WHEREAS WE the said J. E. Greer and Callie S. Greer

in and by ~~US~~ OUR certain promissory note, in writing, of even date with these presents, ~~WE~~ have well and truly indebted to FIDELITY FEDERAL SAVINGS

AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of SEVEN HUNDRED & NO/100

(\$700.00) Dollars,

with interest at the rate of six (6%) per centum per annum to be repaid in installments of FOURTEEN & NO/100

(\$14.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, near the City of Greenville, on the southern side of the Easley Bridge Road, being shown as Lot No. 69 on plat of property of J. Rowley Yown made by Dalton & Neves, Engineers, in April, 1928, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of the Easley Bridge Road, 90 feet east from the corner of Julian Avenue, at the corner of Lot No. 70, and running thence with the line of said lot, S. 30-55 E. 200 feet to an iron pin in line of Lot No. 68; thence with the line of said lot, N. 60 E. 100 feet to an iron pin, corner of Lot No. 52; thence with the line of said lot, N. 30-55 W. 200 feet to an iron pin on the Easley Bridge Road; thence with the southern side of the Easley Bridge Road, S. 60 W. 100 feet to the beginning corner; being the same property conveyed to J. E. Greer and Callie S. Greer by Reuben G. Stone by deed dated January 23, 1929, and recorded in the R. M. C. Office for Greenville County in Book of Deeds "136" at Page 452.
