I, Cora H. Dodson

SEND GREETINGS:

WHEREAS I, the said Cora H. Dodson

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of *and* Twenty-two and 00/100

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Seventeen and 57/100

(*17.57*) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said Cora H. Dodson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said Cora H. Dodson in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in Plat Book H at page 177, and having according to said plat the following metes and bounds to wit: Beginning at an iron pin on the East side of Townes Street, joint corner of Lots Nos. 25 and 26, and running thence along the rear lines of Lots Nos. 22, 23, 24 and 25, S. 65-30 E. 207.2 feet to an iron pin, joint rear corner of Lots Nos. 21, 22 and 26; thence S. 24-30 W. 110 feet to an iron pin; thence N. 65-30 W. 180.8 feet to an iron pin on the East side of Townes Street; thence along the East side of Townes Street N. 10-57 E. 113.2 feet to the beginning; being the same lot of land conveyed to Elizabeth E. Beaty by Franklin Real Estate & Investment Company by deed dated 1st June, 1937, recorded in Book 194, page 49, R. M. C.
