NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **X**, State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being at the Southeast corner of the intersection of Oakhurst Avenue and Buist Avenue, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 15 on plat of Oakhurst Subdivision, made by Dalton & Neves, Engineers, October, 1936, and recorded in the R. M. C. Office for Greenville County S. C., in Plat Book I, at page 84, and having, according to said plat and a recent survey made by A. Newton Stall, July 26, 1939, the following metes and bounds, to-wit:-

BEGINNING at an iron pin at the Southeast corner of the intersection of Oakhurst Avenue and Buist Avenue, and running thence with the South side of Buist Avenue, S. 65-16 E. 50 feet to an iron pin; thence with line of Lot No. 16, S. 29-03 W. 161.7 feet to an iron pin; thence N. 65-06 W. 55 feet to an iron pin on the East side of Oakhurst Avenue; thence with the East side of said Avenue, N. 30-49 E. 162 feet to the beginning corner.
