All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about two and one half miles West of the Town of Greer, on the North side of the Super Highway, and being the same lot conveyed to me this day by deed from J. W. Hood, and being known and designated as lot number two on plat of W. E. McIntyre property, and having the following courses and distances, to wit:
