

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, G. P. Peterson, of Greenville County, South Carolina, SEND GREETINGS:

WHEREAS I, the said G. P. Peterson

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of TWO THOUSAND & NO/100

(\$ 2,000.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of TWENTY & NO/100

(\$20.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection of said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said G. P. Peterson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said G. P. Peterson

in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Bates Township, on the North side of the Buncombe Road, just North of Travelers Rest, being known and designated as Lot No. 38 on plat of Property of Love Estates made by W. J. Riddle, Surveyor, in April, 1938, recorded in the R. M. C. Office for Greenville County in Plat Book "I" at Pages 111 and 112, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the North side of the Buncombe Road, which pin is 588 feet Southwest from the intersection of Tubbs Mountain Road and the Buncombe Road, at corner of Lot No. 39, and running thence with the line of said lot, N. 36-21 W. 200 feet to corner of Lot No. 63; thence with the rear line of said lot, S. 53-39 W. 100 feet to corner of Lot No. 37; thence with the line of said lot, S. 36-21 W. 200 feet to the Buncombe Road; thence with the Northern side of the Buncombe Road, N. 53-39 E. 100 feet to the beginning corner; being the same property conveyed to G. P. Peterson by W. Raymond Williams, Jr., Trustee, by deed dated August 14, 1939, and recorded in the R. M. C. Office for Greenville County in Book of Deeds "216" at Page 125.
