I, Lula M. Hill, of the City of Greenville, County of/

SEND GREETINGS:

WHEREAS I the said Lula M. Hill

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C. in the full and just sum of EIGHTEEN HUNDRED & NO/100

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of EIGHTEEN & NO/100 1800.00 Dollars,

(\$18.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I the said Lula M. Hill

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said Lula M. Hill

in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the East side of Fairview Avenue (formerly Gibson Street), in the City of Greenville, being shown as Lot No. 7 on plat of Property of Charlotte M. Goldsmith made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book F at page 47, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the East side of Fairview Avenue, at corner of Lot No. 8, and running thence with the line of said lot, S. 85-0 E. 227 feet to an iron pipe in line of Lot No. 10; thence with the line of said lot, S. 3-33 W. 69-66 feet to an iron pin in line of property now or formerly owned by J. W. Norwood; thence with the line of said property N. 85-0 W. 227 feet to an iron pin on Fairview Avenue; thence with the Eastern side of Fairview Avenue, N. 3-33 E. 69.66 feet to the beginning corner; being the same property conveyed to Lula M. Hill by C. G. Berry by deed recorded herewith.

And the mortgagor(s) hereby agree, on demand of the mortgagee at any time, to pay, on the first day of each succeeding month thereafter, together with, and in addition to, the monthly payment of principal and interest, a sum equal to one-twelfth (1/12th) of the said annual sum, and also to pay, on demand, any and all additional sums necessary to pay those items. It is further agreed that any such additional sums, when so demanded by the mortgagee, shall become a part of the monthly installment and interest payments of this mortgage and the note secured thereby.
