SEND GREETINGS:

WHEREAS I the said A. O. Barbare

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE in the full and just sum of

ONE THOUSAND, EIGHT HUNDRED AND NO/100

(\$ 1,800.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

EIGHTEEN AND NO/100

(\$ 18.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the north side of Parker Road, joint corner of Lots 38 and 39, which point is 100 feet west from the northwest intersection of Parker Road and Center Street, and running thence along said Parker road, N. 37-06 W. 100 feet to an iron pin, joint corner of Lots 40 and 41, which point is 100 feet east from the northeast intersection of Parker Road and Power street; thence along the line of Lot 41, N. 62-30 E. 150 feet to an iron pin; thence S. 37-06 E. 100 feet to an iron pin; thence S. 62-30 W. 150 feet to the beginning corner. Being the same two lots conveyed to me by The Carolina Loan and Trust Company by deed dated July 18, 1936 and recorded in the R. M. C. Office for Greenville County in Vol. 185, page 239."
