in and by my certain promissory note, in writing, of even date with these presents, I am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of TWO THOUSAND AND NO/100

(\$ 2,000.00 ) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of TWENTY AND NO/100

( \$ 20.00 ) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I R. S. Eassy, the said

City of Greenville, being known and designated as Lot No. 41 of the subdivision of "Eastover" as shown by plat recorded in the R. M. C. Office for Greenville County in Plat Book "F" at Page 42, said lot having a frontage of 60.1 feet on Beechwood Avenue, a depth of 162.9 feet along the line of Lot No. 42, a depth of 159.7 feet along the line of Lot No. 40, and a width of 60.1 feet in the rear.

"This is the same lot of land conveyed to the mortgagor by the Fidelity Federal Saving & Loan Association by deed of even date, yet to be recorded, and the within mortgage is given to secure balance of purchase price."

And the mortgagor(s) do hereby agree, on demand of the mortgagee or any assignee, to pay, on the first day of each month hereafter, until the principal sum, with interest, has been paid, a sum equal to the monthly payments of principal and interest stated above, a sum equal to the monthly (1/12th) of the said annual interest assessment and insurance premium, as estimated by the mortgagee(s); further agree(s) to pay on demand, at any time, any additional sums necessary to pay these notes. It is further agreed that any such additional payments, when so demanded by the mortgagee, shall become a part of the monthly installments due under the terms of this mortgage and the note secured thereby.
