TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, L. W. Bolt

SEND GREETINGS:

WHEREAS I, the said L. W. Bolt

in and by my certain promissory note, in writing, of even date with these presents, and well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Twenty-four Hundred Thirty-Six and 92/100

(\$ 2,436.92) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Twenty-Nine and no/100

(\$ 29.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said L. W. Bolt

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said L. W. Bolt

in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Butler Township, on the Laurens Road, near the City of Greenville, and known as Lot No. 6 of Block "C" in the subdivision of Carolina Court, a plat of said subdivision being of record in the R. M. C. Office for Greenville County in Plat Book "F" at Page 96 to which plat reference is made for metes and bounds:

"This is the same lot of land conveyed to the American Building & Loan Association by L. V. Brown by his deed dated May 18, 1936 recorded in the R. M. C. Office for Greenville County in Volume 191, Page 336."

"This is the same lot of land conveyed to the mortgagor by the Fidelity Federal Savings & Loan Association by its deed of even date, yet to be recorded, and the within mortgage is given to secure the balance of purchase price.

And the mortgagor(s) do hereby agree, on demand of the mortgagee at any time, to pay the first day of each succeeding month hereafter, together with, and in addition to, the monthly amount of principal and interest stated above, a sum equal to one-twelfth (1/12th) of the said taxes, assessments and insurance premiums, as estimated by the mortgagee. The mortgagor(s) agree(s) to pay on demand, at any time, any additional sums necessary to pay these items. It is further agreed that any such additional payments, when so demanded by the mortgagee, shall become a part of the monthly installments due under the terms of this mortgage and the note secured thereby.
