I, W. E. Caldwell, of Greenville County, State of South Carolina SEND GREETINGS:

WHEREAS I, _____ the said W. E. Caldwell

in and by my _____ certain promissory note, in writing, of even date with these presents, am _____ well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of SEVEN HUNDRED, FIFTY & NO/100

(\$ 750.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of TEN & NO/100

(\$ 10.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Saluda Dam Road, near the City of Greenville, containing 10.50 acres, more or less, according to survey made by R. E. Dalton, E. E., in December, 1937, and having the following metes and bounds:

Beginning at a stake in the center of Saluda Dam Road, at corner of property of J. O. Gauble Estate, and running thence with Saluda Dam Road S. 48-45 W. 650 feet to bend in Road; thence continuing with said Road, S. 71 W. 650 feet to bend in Road; thence S. 37-08 W. 294 feet to a stake on right-of-way of the Southern Railroad (which right-of-way is 100 feet from center of track); thence with the Northern side of the right-of-way of the Southern Railroad N. 88-10 E. 1117 feet to an iron pin in line of property of J. O. Gauble Estate; thence with the line of said property N. 11-30 E. 857 feet to the beginning corner; being the same property conveyed to W. E. Caldwell by R. A. Means by deed dated December 6, 1937, recorded in the R. M. C. Office for Greenville County, S. C., in Book of Deeds 200 at Page 494.
