MORTGAGE AND REFUNDING BOND

This Indenture, Made and entered this 25th day of January 1941 by and between W. H. Chastain J. K. Chastain, Brannard Gilreath, Kirby Lindsey, Ernest S. Neves, as Trustees of the Mt. View Methodist Episcopal Church, South, in Greenville County of Greenville, State of S. C., of the first part and the BOARD OF CHURCH EXTENSION OF THE METHODIST EPISCOPAL CHURCH, SOUTH, of the city of Louisville, County of Jefferson, and State of Kentucky, of the second part:

WITNESSETH That, whereas, the parties of the first part do hereby represent and declare that they and their predecessors in office have acquired title to, and do now held, the premises, hereinafter described in trust, and said premises shall be held, kept, maintained and fisposed of as a place of divine worship for the ministers and members-residence for the traveling preachers of the Methodist Episcopal: Church, South, subject to the discipline, usage, and ministerial appointments of said Church, as from time to time authorized and declared by the General Conference of said Church, and the Annual Conference within whose bounds the said premises may be situated.

AND WHEREAS, the party of the second part, in consideration of the uses and purposes to which said premises are devoted, as hereinbefore declared, and of the obligation of this indenture, hereinafter stated, has conditionally donated to the parties of the first part the sum of Two Hundred & Fifty Dollars (\$250.00) to be secured and repaid as hereinafter set out:

Now the parties of the first part, for and in consideration of the premises, and of the sum of money so donated, and in compliance with the terms and conditions which the said Board of Church Extension made said donation, do, for themselves as Trustees, and for their successors in office, hereby covenant, primise and agree, to and with the said parties of the second part that in case the property hereinafter described shall ever hereafter be aliened from the Methodist Episcopal Church, South, or cease to be used for, or be devoted to other uses than, the uses and purposes set forth in the declaration of trust hereinbefore contained, the said parties of the first part shall and will forthwith refund to the parties of the second part, their successors and assigns, the sum of money hereinbefore stated, with interest thereon from the time of such alienation, or from the time of diversion of said property from said uses and purposes in said declaration of trust confained.

They further obligate themselves to insure, and kee p insured, the improvements/against less or damage by fire.

And to secure the performance of their said covenants and abligations above set forth, and in consideration of the premsis.

And said Parties of the First Part have bargained and sold, and do by these presents, grant, alien, and convey unto the party of the second part, the said Beard of Church Extension of the Methodist Episcopal Church, South, all of the following described rear estate, to-wit:

Tract of land adjoining Mountain View School house lot running in same direction of back school house line to to G. V. Bells line, thence with G. V. Bells line to state road, thence with State Road to said Mountain View School House lot, containing two acres more or less.

To Have and to Hold unto said second party, its successors and assigns forever, with covenant of General Warranty of title to same.

This instrument is executed under authority of a resolution of the Quarterly Conference of Pos, St. Johns charge, in the bounds of the Upper S. C. Annual Conference, adopted at a meeting thereof hadd on 11 day of Aug. 1940.

Now, if said party of the first part, or any one of them, shall repay said sum of money so donated, with interest, and insure and keep insured the improvements on said premises as aforesaid, then this indenture shall be void, else remain in full fores.
