TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Delphena Wilkerson

SEND GREETINGS:

Whereas, I the said Delphena Wilkerson

in and by a certain promissory note in writing, of even date with these presents, well and truly indebted to The Farmers Bank of Simpsonville

in the full and just sum of Three Hundred & no/100 (\$300.00) Dollars, to be paid Twenty & no/100 (\$20.00) Dollars per month beginning May 1, 1941 and continuing until note is paid in full

with interest thereon from maturity at the rate of 7 per centum per annum, to be computed and paid annually in advance until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

All that certain piece, parcel or lot of land with the improvements thereon, situate, lying and being, in Greenville County, State of South Carolina, just outside of the City limits of Greenville, S. C., known as #707 Anderson Street and being shown and delineated as Lot #9 of Washington Heights subdivision as shown on plat made by C. M. Furman, Jr., February 3, 1922 and recorded in Plat Book F at page 54; said lot being located at the corner of Anderson and LaFayette Streets, fronting fifty (50) feet on Anderson and running back one hundred (100) feet on LaFayette, as shown on the plat and being the same lot conveyed to me by J. W. Norwood by deed dated Nov. 6, 1933 and recorded in the Office of R. M. C. for Greenville County in Vol. 115 at page 576, to which reference is hereby craved as pertains to further description.
