being known and designated as Lots Nos. 30, 32, 33, 34 and 43 as shown on revised plat of Shannon Terrace made by H. S. Brockman, Surveyor, dated January, 1930, and revised by R. E. Dalton in June, 1935.

Lots 30, 32, 33 and 34 have the following metes and bounds, to-wit:

Beginning at a stake on the south side of Hill Top Drive at corner of Lot No. 31 and running thence along line of said lot S. 29 W. 125 feet to a stake; thence S. 61 E. 37 feet to a stake on the north side of Brookview Circle; thence along said north side of Brookview Circle, S. 39-30 W. 65 feet to a stake at bend; thence S. 72-20 W. 50 feet to stake at bend; thence S. 79 W. 108.7 feet to stake; thence continuing along the north side of Brookview Circle S. 89 W. 60.5 feet to stake at corner of Lot No. 36; thence N. 29 E. 166.5 feet to a stake at corner of Lot No. 28; thence S. 61 E. 100 feet to a stake; thence N. 29 E. 150 feet to a stake on the south side of Hill Top Drive; thence S. 61 E. 50 feet to the beginning corner.

Lot No. 43 has the following metes and bounds, to-wit:

Beginning at a stake on the east side of Brookview Circle at corner of Lot No. 44 and running thence along the line of said Lot No. 44 N. 80-21 E. 199 feet to a stake on the west side of Hill Top Drive; Thence S. 54-55 W. 216.8 feet to a stake on the east side of Brookview Circle; thence along said east side of Brookview Circle N. 11 W. 100 feet to the beginning corner.
