I, Oscar Hodges, Jr., as Trustee for Vardry McBee, of Greenville, S. C. SEND GREETINGS:

WHEREAS I, _____ the said Oscar Hodges, Jr., as Trustee for Vardry McBee

in and by my _____ certain promissory note, in writing, of even date with these presents, am _____ well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of TWENTY-SIX HUNDRED & NO/100

(\$ 2,600.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of THIRTY-ONE & NO/100
