WHEREAS I J. R. Ellis

in and by my \_\_\_\_\_ certain promissory note, in writing, of even date with these presents, am \_\_\_\_\_ well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Twenty-five Hundred & No/100 (\$ 2500.00 ) Dollars,

with interest at the rate of (6%) per centum per annum, to be repaid in installments of Twenty-five & No/100 (\$ 25.00 ) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

BEGINNING at an iron pin on the West side of the New Buncombe Road corner of Lot No. 4, and running thence with the line of said lot, S. 26-15 W. 642.4 feet to an iron pin on a 40 foot street; thence with the Eastern side of said street, S. 38-51 E. 75.12 feet to a stake; thence N. 26-15 E. 642.6 feet to an iron pin on the New Buncombe Road; thence with the Western side of the New Buncombe Road, N. 39-03 W. 75 feet to the beginning corner, containing one acre, more or less, being the same property conveyed to J. R. Ellis by E. C. Ellis by deed dated September 17, 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Book of Deeds 237 at Page 274."
