All that piece, parcel or lot of land situate, lying and being in the Augusta Road section on East Tallulah Drive, and being known as Lot 29, on the subdivision of the lands of the Estate of D. T. Smith, as shown on plat of same recorded in plat book "H", page 289, in Office of RMC for Greenville County; said lot being more fully described by metes and bounds, as follows:

Beginning at an iron pin on the south side of East Tallulah Drive, at the joint corners of Lots 25 and 29 and running thence S. 64-40 W. with East Tallulah Drive 100 feet to iron pin; thence S. 25-20 E. along joint lines of Lots 25 and 29, 200 feet to iron pin at joint corners of Lots 25, 26, 29 and 30; thence along joint lines of Lots 29 and 30, N. 64-40 E. 100 feet to iron pin at joint corners of Lots 29, 30, 31 and 32; thence along joint lines of Lots 29 and 31, N. 25-20 W. 200 feet to iron pin on East Tallulah Drive, which is the beginning corner.
