All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of Bates Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 35 on plat of Skyland Park made by Dalton & Neves, Engineers, March, 1941, recorded in the R.
