REAL ESTATE MORTGAGE FOR SOUTH CAROLINA

KNOW ALL MEN BY THESE PRESENTS:

That, whereas the undersigned, Roy R. Cooper

of the county of Greenville, State of South Carolina, hereinafter called Mortgagor, has become justly indebted to the United States of America, acting by and through the Secretary of Agriculture, pursuant to the provisions of Title I of the Bankhead-Jones Farm Tenant Act, hereinafter called Mortgagee as evidenced by one certain promissory note, dated the 9th day of February, 1942 for the principal sum of Fifty-seven Hundred Thirty-five and No/100 Dollars (\$ 5,735.00), with interest at the rate of three per cent (3%) per annum, principal and interest payable and amortized in installments as therein provided, the first installment of Two Hundred Forty-eight and 10/100 Dollars (\$ 248.10) being due and collectible on the 31st day of December, 1942 the next succeeding thirty-eight installments, annually thereafter, and the fortieth installment, either thirty-nine years thereafter or forty years from the date of said note, whichever date is the earlier; and

WHEREAS, Mortgagor is desirous of securing the prompt payment of said note, and the several installments of principal and interest at maturity, and any extensions or renewals thereof, and any agreements supplementary thereto, and any additional indebtedness accruing to Mortgagee on account of any future advances or expenditures made as hereinafter provided, and the performance of each and every covenant and agreement of Mortgagor herein contained.

NOW, THEREFORE, in consideration of the said indebtedness and to secure the prompt payment thereof, as the same matures or becomes due, and of any extension or renewal thereof, or of any agreement supplementary thereto, and to secure the performance of each and every covenant and agreement of Mortgagor herein contained, Mortgagor has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mortgagee

the following described real estate situated in the county of Greenville, State of South Carolina, to-wit:

All that certain piece, parcel or lot of land situate, lying and being in Austin Township, County of Greenville, State of South Carolina, containing 72.87 acres, more or less, according to a survey made by W. J. Riddle, April, 1924, plat of survey being recorded in Book 1, page 167, public records of Greenville County, South Carolina, and being shown on said survey as Tract No. 4, and the greater portion of Tract No. 5 on plat of the Estate of W. A. Pollard, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in Pelham Road at the corner of property of F. L. Smith and running thence with said Smith line South 81 degrees 30 minutes East 590 feet to an iron pin; thence South 2 degrees 15 minutes West 178 feet to an iron pin; thence continuing with the said Smith property South 87 degrees 00 minutes East 343 feet to a stone; thence still with said Smith property South 57 degrees 00 minutes East 610 feet to an iron pin; thence still with the said F. L. Smith property South 30 degrees 30 minutes West 582 feet to an iron pin at corner of land now or formerly of Painter; thence with the line of Painter, Hawkins and Stokes properties South 54 degrees 00 minutes East 1423 feet to an iron pin at corner of land now or formerly of J. O. Gresham; thence with the said Gresham line North 38 degrees 45 minutes East 547 feet to an iron pin corner of Tract No. 2 on plat above mentioned; thence with the line of Tract No. 2 North 39 degrees 30 minutes West 577 feet to an iron pin corner of Tracts No. 1 and 2; thence with the line of Tract No. 1, North 39 degrees 30 minutes West crossing a branch, 1328 feet to an iron pin; thence still with the line of Tract No. 1, recrossing said branch, North 44 degrees 45 minutes East 929 feet to an iron pin in the center of a road; thence still with the line of Tract No. 1, North 50 degrees 45 minutes East 580 feet to an iron pin; thence North 85 degrees 00 minutes West 1219 feet to a stake in the center of a county road; thence continuing with said road North 69 degrees 30 minutes West 315 feet to a point in the Pelham Road, where said county road intersects with the Pelham Road; thence with the Pelham Road South 43 degrees 30 minutes West 4 feet to a point; thence continuing with the Pelham Road South 33 degrees 00 minutes West 272 feet to an iron pin, joint corner of Tracts No. 4 and 5; thence continuing with the Pelham Road South 33 degrees 00 minutes West 307.5 feet to an iron pin on the Southeast edge of said road; thence South 6 degrees 45 minutes East 32 feet to a gun barrel near the Southeast edge of the Pelham Road; thence South 38 degrees 00 minutes West 1429 feet to an iron pin in the Pelham Road, the beginning corner. Being bounded on the Northwest by Pelham Road, on the South and Southwest by property now or formerly of F. L. Smith and property now or formerly of Painter, Hawkins and Stokes and the Southeast by property of J. O. Gresham and on the North by Tracts No. 1 and 2 on the plat abovementioned, the remaining portion of Tract No. 5 and a county road. R.R.C.

Being the same land that was conveyed to Roy R. Cooper by a certain deed made by Letha Pollard Boling and F. H. Boling, dated January 23rd, 1942, and intended to be recorded simultaneously herewith;

together with all rents and other revenues or incomes therefrom, and all and singular the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident or appertaining, and all improvements and personal property now or hereafter attached to or reasonably necessary to the use of the real property herein described, all of which property is sometimes hereinafter designated as "said property";

TO HAVE AND TO HOLD, all and singular, said property before mentioned unto Mortgagee and its assigns forever.

MORTGAGOR, for himself, his heirs, executors, administrators, successors and assigns, does hereby warrant and forever defend all and singular the said property unto Mortgagee against every person whomsoever lawfully claiming or to claim the same, or any part thereof, and does hereby and by these presents covenant and agree:

- To pay, before the same shall become delinquent, all taxes, assessments, levies, liabilities, obligations and encumbrances of every nature whatsoever which affect said property or the Mortgagee's rights and interests therein under this Mortgage or the indebtedness hereby secured, and promptly to deliver to Mortgagee, without demand, receipts evidencing such payments.
- Immediately upon the execution of this mortgage to provide, and thereafter continuously to maintain fire insurance policies and such other insurance policies as Mortgagee may then or from time to time require upon the buildings and improvements now situate or hereafter constructed in or upon said Property. Said fire and other insurance policies shall be deposited with the Mortgagee and shall be with companies in amounts and on terms and conditions approved by Mortgagee.
- Personally and continuously to use said property as a farm, and for no other purpose; at all times to maintain said property in proper repair and good condition; to commit or suffer no waste or exhaustion of said property; neither to cut nor remove any timber therefrom, nor to remove, or permit to be removed, gravel, oil, gas, coal or other minerals, except such as may be necessary for ordinary domestic purposes, promptly to effect such repairs to said property as Mortgagee may require; to institute and carry out such farming practices and farm and home management plans as Mortgagee shall, from time to time, prescribe; and to make no improvements upon said Property without consent by Mortgagee.
- To perform, comply with and abide by each and every stipulation, agreement, condition and covenant in said promissory note, and in any extensions or renewals thereof, and in any agreements supplementary thereto, and in any loan agreement executed by Mortgagee on account of said indebtedness, and in this mortgage contained.
- To comply with all laws, ordinances and regulations affecting said property or its improvements.
- That the indebtedness hereby secured was, expressly loaned by the Mortgagee to the Mortgagor for the purpose of purchasing this said property, and that the Mortgagor did use said moneys to purchase same.
- The Mortgagee, its agents and attorneys, shall have the right at all times to inspect and examine said property for the purpose of ascertaining whether or not the security given is being lessened, diminished, depleted or impaired, and if such inspection or examination shall disclose, in the judgment of the Mortgagee that the security given or property mortgaged is being lessened or impaired, such conditions shall be deemed a breach of the covenants of the mortgage on the part of the Mortgagor.
- That all of the terms and provisions of the note which this mortgage secures, and of any extensions or renewals thereof, and of any agreements supplementary thereto, and of any loan agreement executed by Mortgagor on account of said indebtedness, are hereby incorporated in and made a part of this mortgage as if the same were set out in full herein, and shall be construed with said Mortgage as one instrument.
- That without Mortgagee's consent, no final payment of the indebtedness herein secured shall be made, nor shall a release of Mortgagee's interest in and to said property or lien be made, within five years from and after the date of the execution of this mortgage.
- That all awards of damages up to the amount of the indebtedness of Mortgagor to Mortgagee in connection with any condemnation for public use of or injury to any of said property are hereby assigned and shall be paid to Mortgagee who may apply same to payment of the installments last to become due under said note, and Mortgagee is hereby authorized, in the name of Mortgagor, to execute and deliver valid acquittances therefor and to appeal in the name of Mortgagor or Mortgagee from any such award.
