AND IT IS COVENANTED AND AGREED by and between the parties hereto that all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, elevators and motors, bath-tubs, sinks, water-closets, basins, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels, refrigarating plant and ice-boxes, cooking apparatus and appurtenances, and such other goods and chattels and personal property as are ever furnished by a landlord in letting or operating an untraished building, similar to the case herein described and referred to, which the realty as between the parties hereto, their heirs, executors, administrators, successors and assigns, and all persons claiming by, through or under them, and shall be deemed to be a portion of the

TO HAVE AND TO HOLD the said premises and every part thereof with the appurtenances unto the said Mortgagee, its successors, legal representatives and assigns forever.

PROVIDED ALWAYS, that if the said Mortgagor, heirs, executors, administrators, successors or assigns, shall pay unto the said Mortgagoe, its successors or assigns, the said shall cease, determine and be void.

AND the said Mortgagee, its successors, legal representatives or assigns, shall also be at liberty, immediately after any such default, upon a complaint filed or any other proper legal prosecting being commenced for the foreclosure of this mortgage, to apply for, and the said Mortgagee shall be entitled as a matter of right, without consideration of the value of the surging propers as security for the amounts due the Mortgagee, or of the solvency of any person or persons bonded for the payment of such amounts, to the appointment by any competent Court or Principal propers as may be deemed necessary, who, after deducting all proper charges and expenses attending the execution of the said premises, or such part thereof as may not then be under lease, and with such other to the payment and satisfaction of the amount remaining secured hereby, or to any deficiency which may exist after applying the proceeds of the said premises of the said mortgaged premises and to let the said mortgage, its successors or assigns, who shall have the right fagiliarith after may sheet of the said premises and expenses, on account of the amount hereby secured.

AND it is further covenanted and agreed that the whole of said principal sum and the interest shall become due, at the option of the said Mortgages, upon failure of any owner of the above
