We, W. A. Yown and Helen W. Yown, of Greenville SEND GREETINGS:

WHEREAS ~~we~~ the said W. A. Yown and Helen W. Yown

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of Two Thousand, Three Hundred & No/100

(\$2,300.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of Twenty-Three and No/100 (\$ 23.00) Dollars upon the first

C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, being known and designated as Lot No. 22, on the 26th DAY OF FEBRUARY, 1944, Property of Next M. Ferry, Trustee, as recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book I, at page 33, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Rogers Avenue, at the joint corner of Lots 22 and 23, which point is 290 feet west of the northwest intersection of Rogers Avenue with the New Buncombe Road, and running thence along the joint line of said lots, N. 10-17 W. 150 feet to an iron pin; thence S. 79-28 W. 50 feet to an iron pin, joint rear corner of Lots 21 and 22; thence along the joint line of said lots, S. 10-17 E. 150 feet to an iron pin on the north side of Rogers Avenue; thence along the line of said Rogers Avenue N. 79-28 E. 50 feet to the beginning corner. Being the same lot conveyed to us by R. L. Hughes, by deed of even date herewith, not yet recorded."
