Also, all that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, about three and three-fourths miles from Greenville County Court House, on the west side of the Buncombe Road, and having the following metes and bounds, to-wit:
