WHEREAS I, the said J. W. Page

in and by my certain promissory note, in writing, of even date with this well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of

with interest at the rate of (6%) per centum per annum, to be repaid in installments of Ten and No/100
