REAL ESTATE MORTGAGE FOR SOUTH CAROLINA

KNOW ALL MEN BY THESE PRESENTS:

That, whereas the undersigned, Berry L. Knight

of the county of Greenville, State of South Carolina, hereinafter called Mortgagor, has become justly indebted to the United States of America, acting by and through the Secretary of Agriculture, pursuant to the provisions of Title I of the Bankhead-Jones Farm Tenant Act, hereinafter called Mortgagee as evidenced by one certain promissory note, dated the 18th day of September, 1942 for the principal sum of Forty-five Hundred Forty-five and No/100 (\$4,545.00), with interest at the rate of three per cent (3%) per annum, principal and interest payable and amortized in installments as therein provided, the first installment of One Hundred Fifty-Three and 53/100 (\$153.53) being due and collectible on the 31st day of December, 1943, the next succeeding thirty-eight installments, annually thereafter, and the fortieth installment, either thirty-nine years thereafter or forty years from the date of said note, whichever date is the earlier; and

WHEREAS, Mortgagor is desirous of securing the prompt payment of said note, and the several installments of principal and interest at maturity, and any extensions or renewals thereof, and any agreements supplementary thereto, and any additional indebtedness accruing to Mortgagee on account of any future advances or expenditures made as hereinafter provided, and the performance of each and every covenant and agreement of Mortgagor herein contained.

NOW, THEREFORE, in consideration of the said indebtedness and to secure the prompt payment thereof, as the same matures or becomes due, and of any extension or renewal thereof, or of any agreement supplementary thereto, and to secure the performance of each and every covenant and agreement of Mortgagor herein contained, Mortgagor has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Mortgagee the following described real estate situated in the county of Greenville, State of South Carolina, to-wit:

All that piece, parcel or lot of land in Dunklin Township, Greenville County, South Carolina, known as the J. E. Gossett place located on the Holliday Bridge Road, 7 miles from Belton, South Carolina on waters of Saluda River, bounded on the North by lands of W. L. Martin, on the east by lands of P. C. Stokes, on the South by lands of W. E. Gossett, on the West by lands of W. L. Martin and T. C. Chapman, and having the following courses and distances according to survey and plat made by W. J. Riddle, October 5, 1933, recorded in Plat Book L, page 199 public records, Greenville County, South Carolina.

BEGINNING at a stone on public road running thence with the road North 39 degrees 45 minutes East 11.00 chains to iron pin in Holliday Bridge Road; thence with Holliday Bridge Road North 25 degrees 15 minutes West 14.08 chains to iron pin, W. L. Martin corner; thence with Martin Land South 11 degrees West 9.10 chains to iron pin; thence still with Martin's line South 84 degrees West 13.50 chains to iron pin; thence North 86 degrees West 5.30 chains to iron pin; thence South 82 degrees 45 minutes West 16.07 chains to iron pin on public road; thence with the road North 86 degrees West 11.78 chains to pin; thence South 79 degrees 45 minutes West 10.62 chains to iron pin; thence North 60 degrees 15 minutes West 8.66 chains to poplar; thence North 65 degrees West 1.08 chains to stone; thence South 44 degrees 30 minutes West 3.54 chains to stone; thence South 8 degrees 30 minutes West 3.60 chains to stone; thence South 27 degrees 30 minutes West 5.00 chains to stone; thence South 7 degrees East 5.00 chains to stone; thence South 5.02 chains to stone; thence North 83 degrees 30 minutes East 3.84 chains to stone; thence North 38 degrees 30 minutes East 4.54 chains to stone; thence North 30 degrees 55 minutes East 3.74 chains to stone; thence South 77 degrees 30 minutes East 2.87 chains to stone; thence South 56 degrees West 1.94 chains to stone; thence South 29 degrees 30 minutes West 5.15 chains to stone; thence North 83 degrees 30 minutes East 62.90 chains to stone, the beginning corner, and containing 106 acres.

Being the same land that was conveyed to Berry L. Knight, his Attorney-in-Fact, R. K. Gossett and J. C. Gossett, by R. K. Gossett, dated September 24, 1942, and intended to be recorded simultaneously herewith; together with all rents and other revenues or incomes therefrom, and all and singular the rights, members, tenements and appurtenances thereunto belonging, or in any wise incident or appertaining, and all improvements and personal property now or hereafter situated on or upon said property, and the use of the real property herein described, all of which property is sometimes hereinafter designated as "the premises"; and

TO HAVE AND TO HOLD, all and singular, said property before mentioned unto Mortgagee and its assigns, does hereby warrant and forever defend all and singular the said property unto Mortgagee against every person whomsoever lawfully claiming or to claim the same, or any part thereof, and does hereby and by these presents covenant and agree:

- To pay, before the same shall become delinquent, all taxes, assessments, levies, liabilities, obligations and encumbrances of every nature whatsoever which affect said property or the Mortgagee's rights and interests therein under this Mortgage or the indebtedness hereby secured, and promptly to deliver to Mortgagee, without demand, receipts evidencing such payments.
- Immediately upon the execution of this mortgage to provide, and thereafter continuously to maintain fire insurance policies and such other insurance policies as Mortgagee may then or from time to time require upon the buildings and improvements now situate or hereafter constructed in or upon said Property. Said fire and other insurance policies shall be deposited with the Mortgagee and shall be with companies in amounts and on terms and conditions approved by Mortgagee.
- Personally and continuously to use said property as a farm, and for no other purpose; at all times to maintain said property in proper repair and good condition; to commit or suffer no waste or exhaustion of said property; neither to cut nor remove any timber therefrom, nor to remove, or permit to be removed, gravel, oil, gas, coal or other minerals, except such as may be necessary for ordinary domestic purposes; promptly to effect such repairs to said property as Mortgagee may require; to institute and carry out such farming practices and farm and home management plans as Mortgagee shall, from time to time, prescribe; and to make no improvements upon said Property without consent by Mortgagee.
- To perform, comply with and abide by each and every stipulation, agreement, condition and covenant in said promissory note, and in any extensions or renewals thereof, and in any agreements supplementary thereto, and in any loan agreement executed by Mortgagor on account of said indebtedness, and in this mortgage contained.
- To comply with all laws, ordinances and regulations affecting said property or its use.
- That the indebtedness hereby secured was expressly loaned by the Mortgagee to the Mortgagor for the purpose of purchasing this said property, and that the Mortgagor did use said moneys to purchase same.
- The Mortgagee, its agents and attorneys, shall have the right at all times to inspect and examine said property for the purpose of ascertaining whether or not the security given is being lessened, diminished, depleted or impaired, and if such inspection or examination shall disclose, in the judgment of the Mortgagee that the security given or property mortgaged is being lessened or impaired, such conditions shall be deemed a breach of the covenants of the mortgage on the part of the Mortgagor.
- That all of the terms and provisions of the note which this mortgage secures, and of any extensions or renewals thereof, and of any agreements supplementary thereto, and of any loan agreement executed by Mortgagor on account of said indebtedness, are hereby incorporated in and made a part of this mortgage as if the same were set out in full herein, and shall be construed with said Mortgage as one instrument.
- That without Mortgagee's consent, no final payment of the indebtedness herein secured shall be made, nor shall a release of Mortgagee's interest in and to said property or lien be made, within five years from and after the date of the execution of this mortgage.
- That all awards of damages up to the amount of the indebtedness of Mortgagor to Mortgagee in connection with any condemnation for public use of or injury to any of said property are hereby assigned and shall be paid to Mortgagee who may apply same to payment of the installments last to become due under said note, and Mortgagee is hereby authorized, in the name of Mortgagor, to execute and deliver valid acquittances therefor and to appeal in the name of Mortgagor or Mortgagee from any such award.
