"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, on the North side of a new cut road leading from Mountain Creek Baptist Church to Greenville County Courthouse, adjoining lands now or formerly owned by Will Roberts, John Littleton, and Duke Batson, containing one (1) acre, more or less, according to survey made by G. A. Ellis, Surveyor, November 18, 1940, and described as follows:

Beginning at a stake on the North side of said new cut road, corner of property now or formerly owned by Clapp, and running thence with the Northern side of said new cut road in a Northeasterly direction 420 feet, more or less, to a stake in line of property of Will Roberts; thence with the line of said property, N. 85 W. 390 feet to a stake, corner of Clapp property; thence with the line of said property due South 226 feet to the beginning corner; being the same property conveyed to John Freeman Littleton by Mettar Batson by deed dated September 4, 1941.

ALSO: All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, fronting on road leading from Reid School House to Sandy Flat, adjoining lands of John Leftis on the east, by lands now or formerly owned by J. M. Jones on the south and west, Buck Horn Creek as the line on the north, and having the following metes and bounds:

Beginning on a stone on south bank of Buck Horn Creek near old bridge place on old road leading to Travelers Rest, thence S. 20 1/2 E. 3.50 chains to a stone and plum bush on east edge of said old road, thence S. 84 1/2 E. .84 of a chain to a point in the center of new road leading from Reid School House to Sandy Flat, thence S. 10 E. 2.40 chains to point in the middle of said new road, thence S. 79 W. 4.34 chains to a stone on hill-top in edge of a field, thence N. 59 1/2 W. 4.87 chains to a wild cherry on south bank of Buck Horn Creek at mouth of a ditch, thence down the meanders of said creek to the beginning corner, and containing 3.17 acres, more or less, according to survey made by J.
