in and by my certain promissory note, in writing, of even date herewith, presents, am

with interest at the rate of (6%) per centum per annum, to be repaid in installments of

Twenty-five and No. 00/100

(\$ 25.00) Dollars upon the first day of each and every calendar month hereafter until the full principal and interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Greenville Township, near the City of Greenville, being shown as Lot No. 26 on Plat of property of G. F. Cammer, made by R. E. Dalton, C. E., in February, 1923, recorded in Plat Book L, page 115, and having the following metes and bounds:

BEGINNING at a stake on the northwestern side of Cammer Avenue, 150 feet Southwest from Marietta Street, at corner of Lot No. 25, and running thence with the line of said lot N. 48-48 W. 194.4 feet to a stake in line of the Jenkinson property; thence with the line of said property S. 44-17 W. 75.1 feet to a stake, corner of Lot No. 27; thence with the line of said lot S. 48-48 E. 197.8 feet to a stake on Cammer Avenue; thence with the northwestern side of Cammer Avenue, N. 41-12 E. 75 feet to the beginning corner; being the same property conveyed to the mortgagor by deed, by G. F. Cammer, of even date to be recorded herewith.
