WHEREAS, the Mortgagor is well and truly indebted unto **The Prudential Insurance Company of America,**

a corporation organized and existing under the laws of **the State of New Jersey**, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of

**Thirty-four Hundred Fifty and no/100 Dollars (\$ 3,450.00)**, with interest from date at the rate of **four and one-half** percentum (**4½** %) per annum until paid, said principal and interest being payable at the office of **The Prudential Insurance Company of America** in **Newark, N. All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of King Avenue, within the corporate limits of the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 27 on plat of Parkview, made by Dalton & Neves, Engineers, June 1942, and recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book M, at page 49, and having, according to said plat, and a recent survey made by R. E. Dalton, December 18, 1942, the following metes and bounds, to-wit:

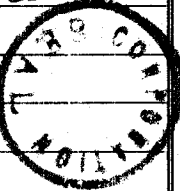
BEGINNING at an iron pin on the Northeast side of King Avenue, at joint front corner of Lots No. 26 and 27, said pin also being 175 feet in a Southeasterly direction from the point where the Northeast side of King Avenue intersects with the Southeast side of Haviland Avenue, and running thence with the Northeast side of King Avenue, S. 26° 15' E. 50 feet to an iron pin on King Avenue at joint front corner of Lots No. 27 and 28; thence with the line of Lot No. 28, N. 63° 45' E. 150 feet to an iron pin; thence with the rear line of Lots No. 39 and 40, N. 26° 15' W. 50 feet to an iron pin; thence with the line of Lot No. 26, S. 63° 45' W. 150 feet to an iron pin on the Northeast side of King Avenue, the beginning corner.
