all that tract or lot of land in **x** Township, Greenville County, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in the Augusta Road Section, known as lot No. 34 on Mount Vista Avenue on plat of subdivision of Smith property (D.T. Smith) plat of which is recorded in Office of R. M. C. for Greenville County at Page 279 in Plat Book "H".

Beginning at an iron pin on Mount Vista Avenue at joint corner of lots No. 32 and 34 and running thence with Mount Vista Avenue N. 64-40 E. 100 feet to iron pin corner of Earl's lot; thence with Earl's lot N. 25-20 W. 200 feet to iron pin; thence with joint line of lots 34 and 31 S. 64-40 W. 100 feet to iron pin; thence with joint line of lots 32 and 34 S. 25-20 E. 200 feet to the beginning corner. This is the same lot of land conveyed to Thomas T. Goldsmith by Beulah Hunt McDonald on the first day of March 1943 by a deed recorded in the office of the R. M. C. for Greenville County in Book 251 at Page 243. It is likewise the same lot as was conveyed to the mortgagors by the said Thomas T. Goldsmith by a deed dated June 28, 1943 and not yet recorded.
