**All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Southeast side of Cammer Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 39 on plat of Augusta Road Hills, made by Dalton & Neves, Engineers, December 1940, and recorded in the R. M. C. Office of Greenville County, S. C., in Plat Book L, at pages 56 and 57, and having, according to said plat and a recent survey made by R. E. Dalton, July 24th, 1943, the following metes and bounds, to-wit:-**

**BEGINNING at an iron pin on the Southeast side of Cammer Avenue at joint front corner of Lots No. 38 and 39, said pin also being 370 feet in a Northeasterly direction from the point where the Southeast side of Cammer Avenue intersects with the North side of Long Hill Street, and running thence with the Southeast side of Cammer Avenue N. 42-10 E. 60 feet to an iron pin at joint front corner of Lots No. 39 and 40; thence with the line of Lot No. 40, S. 47-50 E. 165 feet to an iron pin; thence with the rear line of Lot No. 54, S. 42-10 W. 60 feet to an iron pin; thence with the line of Lot No. 38, N. 47-50 W. 165 feet to an iron pin on the Southeast side of Cammer Avenue, the beginning corner.**
