C.** or at such other place as the holder of the note may designate in writing, in monthly installments of **Twenty-two and 52/100** Dollars (\$ **22.52**), commencing on the first day of **September**, 19 **43**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **August**, 19 **68**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon situate, lying and being on the Northwest side of Henrietta Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 3 on plat of Augusta Road Hills, made by Dalton & Neves, Engineers, December, 1940, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book L, at pages 56 and 57, and having, according to said plat and a recent survey made by R. E. Dalton, July 24, 1943, the following metes and bounds, to-wit:-

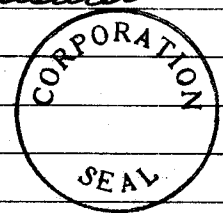
BEGINNING at an iron pin on the Northwest side of Henrietta Avenue at joint front corner of Lots No. 2 and 3, and running thence with the Northwest side of Henrietta Avenue, S. 29-23 W. 28.3 feet to an iron pin; thence running along a curved line in a generally Southwesterly direction to a point on the Northeast side of Low Hill Street (the chord of which is S. 83-44 W. 40.6 feet); thence with the Northeast side of Low Hill Street, N. 41-55 W. 176.1 feet to an iron pin; thence with the line of Lot No. 4, N. 48-05 E. 60 feet to an iron pin; thence with the line of Lot No. 2, S. 41-55 E. 190.7 feet to an iron pin on the Northwest side of Henrietta Avenue, the beginning corner.
