That on the 3rd day of November 1943 the Home Owners' Loan Corporation was the owner of and the holder of that certain amortization note executed by B. L. Garrison and Daisy Garrison, dated the 24th day of August, 1934 in the principal amount of \$1156.70, said note being payable to the order of the Home Owners' Loan Corporation. That said note was secured by that certain mortgage from the said B. L. Garrison to the Home Owners' Loan Corporation, dated the 24th day of August, 1934 and recorded on the 28th day of August, 1934, in the Office of the R. M. C. of Greenville County, South Carolina, in Book of Mortgages 239, at page 216.
