All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known as a portion of Lot No. 13 and a small portion of Lot No. 14 of lands of J. O. Heatherly, as shown on Plat recorded in the R. M. C. office for Greenville County in Plat Book "E", page 235, and having the following metes and bounds, to-wit:
