S. C.), by and through the Federal Land Bank of Columbia, as its Agent and Attorney in fact pursuant to the Act of Congress known as Farm Credit Act of 1935 (Sec. 1016h, Title/ U. S. J. Riddle, Surveyor, in September, 1939, a copy of which in on file with The Federal Land Bank of Columbia, and being bounded on the North by lands, now or formerly, of W. C. Hawkins, East by a road separating said two tracts from tracts 7 and 8, South by tract 19 and West by the G. & K. R. R. right of way separating said two tracts from tracts from tract No. 22.
