"BEGINNING at an iron pin on the northeast side of Beechwood avenue at the joint corner of Lots Nos. 5 and 6, which point is approximately 300 feet from the northeast corner of the intersection of said Beechwood avenue with Laurens Road, and running thence along the line of said Lots Nos. 5 and 6, N. 64-35 E. 155.1 feet to an iron pin; thence N. 21-49 W. 60 feet to an iron pin, joint rear corner of Lots Nos. 6 and 7; thence along the joint line of said lots, S. 62-49 W. 162.5 feet to the joint corner of said lots on Beechwood avenue; thence along the line of Beechwood avenue, following the curvature thereof, 55 feet to the beginning corner. Being the same lot conveyed to us by H. W. Hill, et al., by deed dated March 22nd, 1944, recorded in Vol. 325, page 176."
