Verdin to The First Carolinas Joint Stock Land Bank of Columbia, securing the payment of the principal sum of Four Thousand (\$4000.00) Dollars, dated the 19 day of January 1927, and recorded in the public records of Greenville County, State of South Carolina, in R.
