WHEREAS I, Pauline M. Riddle

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

One Thousand, Four Hundred and No/100

(\$ 1,400.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

Fourteen and No/100 (\$ 14.00) Dollars upon the first

and in Butler Township, on the south side of Lowndes Hill Road (also called the Airport Road), and being known and designated as Lots Nos. 41 and 42 of a subdivision known as East Lynne, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book H, at page 195, and having the following metes and bounds, to-wit:

"BEGINNING AT AN IRON PIN ON THE south side of Lowndes Hill Road at the joint corner of Lots Nos. 40 and 41, which point is 150 feet east from the southeast corner of the intersection of Lowndes Hill Road and Lindsay Avenue, and running thence along the joint line of said Lots Nos. 40 and 41, S. 9-14 E. 166 feet to an iron pin, joint rear corner of Lots Nos. 40, 41, 68 and 69; thence N. 81-02 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 42, 43, 66 and 67; thence with the joint line of Lots Nos. 42 and 43, N. 9-14 W. 166.3 feet to an iron pin on the south side of Lowndes Hill Road; thence along the line of said road, S. 80-43 W. 50 feet to the beginning corner. Being the same lot conveyed to me by Walter W. Goldsmith by deed dated July 18, 1944, and not yet recorded."
