WHEREAS, W. M. Shelton and Henry P. Willimon did on July 14, 1943, execute a mortgage to Conestee Mills in the sum of \$50,000.00, recorded in Volume 320 at Page 45, and

WHEREAS, said note and mortgage was on August 2, 1944, assigned to Thomas B. Puckett, assignment recorded in Volume 329 at Page 47, and

Puckett, for and in consideration of the sum of \$4200.00 to us in hand paid, receipt of which is hereby acknowledged, do hereby forever release and discharge the four parcels of land hereinabove referred to, and described by metes and bounds in separate deeds to the four respective grantees, from the lien of the mortgage first above referred to recorded in Volume 320 at Page 45.

It is understood that the above referred to mortgage shall remain a lien upon all the property therein described, with the exception of the four tracts above mentioned, and the several tracts heretofore released either by Conestee Mills, and/or Thomas B. Puckett, Sr.
